Eligibility:

Open to members of Universal 1 Credit Union, Inc. Applicant must be either a high school senior considering post-secondary education at an accredited college or university or enrolled at an accredited college or university in an undergraduate or graduate program.

Entry Requirements:

- 1. Each applicant must complete an application, provide a current transcript or have their guidance counselor confirm and initial GPA, and provide responses to the six (6) application questions in an attached double-spaced typed document.
- 2. Application period is open from December 4, 2024 at 9:00 AM to March 3, 2025 at 5:00 PM. Eastern Time.

Awards:

- 1. Winners will be notified by phone or email provided on the Application on or about April 7, 2025.
- 2. Up to two (2) scholarships in the amount of \$1,000 each will be awarded.
- 3. Scholarship award funds will be deposited directly into the winning member's account.
